

- Your identification document will be required upon arrival on the day of your visit


 Must be in good physical condition and capable of walking without assistance for 1 hour
- Canes, crutches, and wheelchairs are not allowed in the underground galleries
- Should not be pregnant due to the need to wear a safety belt
- Should not have claustrophobia, heart conditions, asthma, or have undergone a tracheotomy
- Long pants (no skirts, dresses, shorts, or bermudas) and long sleeves are mandatory
- Photography, video recording, and audio recording are prohibited
- Personal items such as bags and pouches must remain in vehicles in the parking area.

Information notice on the processing of personal data in the context of authorization requests for access to Andra's sites

The information collected in the information form is recorded in a computerized file by Andra. The legal basis for the processing is legitimate interest justified by the necessity to ensure the security of Andra's sites.

The fields in the information form must be completed as per the instructions given above. Otherwise, your request for access to Andra's sites will not be processed or will be refused.

Personal data collected and processed within this framework is only accessible to authorized personnel who strictly need to know, namely the Andra correspondent responsible for initiating the access request, those in charge of site access security, and the competent authorities.

The data is used exclusively for the management of access authorizations to Andra's sites.

In terms of retention period, identification data (last name, first name, and date of birth) are used as identifiers for individuals external to the Agency, allowing for the retention of historical data without any time limitation. Other data is automatically deleted on the date of expiration of the security clearance issued by the competent State service, without exceeding a maximum duration of three years.

You are also informed that your request for access to Andra's site entails the conduct of an administrative investigation. This investigation will be carried out by the competent State service, in accordance with the applicable legal and regulatory provisions, including articles L.114-1, R.114-1, and R.114-4 of the Internal Security Code. This administrative investigation is intended to verify that no facts concerning you are incompatible with access to the Andra site related to your request.

You are informed that this investigation involves consulting automated personal data processing systems covered by Article 26 of Law No. 78-17 of January 6, 1978, on data processing, files, and liberties, with the exception of identification files.

Within the limits allowed by law, you can access and obtain a copy of data concerning you, except for data related to the administrative investigation. You can also object to the processing of this data, request corrections, or request its erasure. However, you are informed that exercising your rights of objection, correction, or erasure may, as the case may be, lead to the revocation of your authorization to access the Andra site related to your request.
